Sean Dilweg v. Wells Fargo Bank (L.C. # 2010CV1576)

Before Lundsten, Higginbotham and Sherman, JJ.

The Wisconsin Office of the Commissioner of Insurance and the Wisconsin Commissioner of Insurance (“OCI”) move the court to amend the caption to remove all party names and descriptions so that it reads as *In the Matter of the Rehabilitation of Segregated Account of Ambac Assurance Corporation*. We will not amend the caption in this way.

OCI has also filed new motions to dismiss the appeals filed by Eaton Vance Management, Nuveen Asset Management, Restoration Capital Management, and Stone Lion Capital Partners, L.P. (the “LVM Bondholders”) and Federal Home Mortgage (“Freddie Mac”). In our order dated June 18, 2010, we determined that we had jurisdiction of the appeals filed by

the LVM Bondholders and Freddie Mac. We construe the motions filed by OCI to be motions to reconsider that order, and, for the reasons stated in the June 18 order, deny them.

We also note that LVM Bondholders have not filed a statement on transcript. We grant them a short extension of time to do so.

Therefore,

IT IS ORDERED that the motion to amend the caption is denied.

IT IS FURTHER ORDERED that the motions to dismiss the appeals filed by the LVM Bondholders and Freddie Mac are denied.

IT IS FURTHER ORDERED that the time for the LVM Bondholders to file a statement on transcript is extended to seven days from the date of this order.
