**PLEASE TAKE NOTICE** that pursuant to Wis. Stat. § 809.10(1)(a), the Petitioner, Wells Fargo Bank, as Trustee of the Bondholders, appeals to the Wisconsin Court of Appeals, District IV, from the whole final order entered on July 16, 2010 in the Circuit Court of Dane County, the Honorable William D. Johnson presiding, denying Wells Fargo Bank's motion for: (i) an

order declaring that the allocation of the insurance policy and surety bond insuring the Las Vegas Monorail Project Revenue Bonds to the Segregated Account of Ambac Assurance Corporation was unlawful and violated the provisions Wis. Stat. § 611.24 or the Equal Protection Clauses of the U.S. and Wisconsin Constitutions; and, (ii) an order allowing Wells Fargo Bank to intervene in the proceeding.

This is not an appeal within Wis. Stat. § 752.31(2).

This is not an appeal entitled to preference by statute.
