- *MAVWA does NOT provide canopies, tables, or chairs.

*MAVWA does NOT provide Wi-Fi access.

*MAVWA does NOT assume responsibility for loss or damage of any kind sustained by vendors.

*Driving vehicles onto the grass is not allowed by the Town of Taos.

*The MAVWA Board of Directors is committed to making the Taos Wool Festival a positive experience for all. Vendors are expected to conduct themselves appropriately and to comply with MAVWA requirements.

*Every Vendor must have a New Mexico Department of Taxation and Revenue C.R.S. Tax I.D. Number, and must collect sales tax at the Taos Wool Festival and pay the collected taxes to the State of New Mexico.

BOOTHS:

1. All structures must be well-constructed and able to withstand wind, rain and snow. Vendors may be held liable for injury and/or damage caused by tents or other property.

2. Extension cords must be appropriately sized: 100'/10 ga., 50'/12 ga, 25'/14 ga.

3. Electrical appliances which draw large amounts of electricity (such as hot plates or microwaves) must be pre-approved, and will be connected on an as-needed basis.

4. Power usage must be limited to the capacity of the electrical service provided. Overloaded circuits may be diconnected at the discretion of the Food Vendor Coordinator. **"NO GENERATORS ALOWED"**

5. Every vendor must bring and display a sign or signs indicating his/her/their business; every booth must display a Town of Taos Special Business License (approved by MAVWA).

6. Every booth and all its merchandise, displays, fixtures, furniture and equipment must be contained within that booth's allotted space.

7. Every booth and its contents are expected to be tidy, in good taste and attractive.

8. Food vendors will flatten cardboard boxes at their booth space for City of Taos employees to pickup and recycle, **all other items will be removed.** The coordinator will monitor the food vendor's area for tidiness, space confinement and electrical usage. Violations will be addressed by the Food Vendor Coordinator and appropriate actions will be made to correct the problem.

PAYMENTS AND REFUNDS:

- * Vendor fees may be partially refunded if a vendor cancels their plans to attend the Taos Wool Festival.
- * Vendor fees will be refunded on the following schedule:
 - Prior to June 1st; all vendor fees except \$50.00 will be refunded.
 - After August 1st; no fees will be refunded.

AGREEMENT AND RELEASE:

1. I have read this entire application, and all the information I have supplied is true.
