The use, handling and riding of a horse involves a **RISK of PHYSICAL INJURY** to any person undertaking such activities; and that any horse, irrespective of its training and usual past behavior and characteristics, **MAY ACT OR REACT UNPREDICTABLY AT TIMES BASED UPON INSTINCT OR FRIGHT**, which is an inherent risk assumed by a horseback rider. The undersigned assumes such risks and does hereby fully release and discharge Hermann Park Stables, its owners and employees and their successors and assigns from any claim which the undersigned may assert as a result of physical injury or loss of property incurred in said activities, now or at any time in the future, except to the extent such injury or loss is caused solely and exclusively by the intentional acts of Hermann Park Stables, its owners or employees. The undersigned further agrees to hold Hermann Park Stables harmless for physical injury to others, for property damage, which results from the use by me or my minor child of any horse in violation of any rules at any time in effect at Hermann Park Stables.

Parents **MUST NOT** leave children unsupervised at any time and understand that Hermann Park Stables Inc. **CANNOT** be held responsible for children left unattended.

Under Texas Law (Chapter 87, Live Practice & Remedies Code) an equine professional is not responsible for an injury to or the death of a Participant in equine activities resulting from the inherent risks of equine activities.
