Gen Hightower moves that " the notice from the people of Texas to the OSCE be primarily addressed to Amb. Everts and a carbon copy to the Secretary General of the UN, and a courtesy copy to Attorney general of Texas.

Chairman calls the vote.

Motion carries unanimous.

G. Hightower volunteered the "office for Military Liaison???" to handle the expense and logistics as directed by the people.

Alan moved to accept.

Bill C. seconded.

Chaplain volunteered to witness the signature.

Matt moved to adjourn.
