Subject: Minutes of the meeting of the Texian Jural Society

Date: Tuesday, Fifth day of June, 2012

Location: Warlick Family Dental Clinic, Wimberley, Texas - Hays County

Meeting Convened at 7:15 P.M.

Perry Lang and Katherine Louise, Hamborsky introduced themselves as the chairman and secretary respectively having been elected to the positions at a just previous meeting. As per the discussions at the just previous meeting, the chairman indicated that the first order of business should be the rules for conducting this meeting. Chaplain Raymond introduced a set of rules evidently used by the colony of Pennsylvania in their efforts to ratify the constitution for The United States of America.

Richard Wetzel read articles 1, 2 and 3.

John Rinn read articles 4 and 5.

Alan Hutson read articles 6 thru 8.

Perry Langham stated that he thought the word "States" used in one of the quotations within the document might be the word "nations." There was some discussion and a recommendation to amend the motion. Chuck

Warlick did some on line research, determining that "States" was correct.

Matt stood by original motion.

Somebody called the question.

Vote called.

Chairman conducted a vote.

19 yeahs.

0 nays.

"No abstentions."

John Rinn made a motion and modified it after some discussion as follows:

That the previously approved document "Diplomatic Notice" be submitted to the Secretary of State for the republic State of Texas and subsequent submission to the Hague, if it is approved by a tally of the vote of all assemblies state wide. It is assumed that minor corrections (typing errors, etc) may be made by The secretary of State before submission to the "Hague".

Joe Hoagland seconded the motion as modified.

The question was called.

Chairman conducted a vote.

17 yeahs.

0 nays.

A motion was made to adjourn.

A vote was taken.

Adjourned at 8:45 P.M. Fifth Day of June, 2012.

The meeting was adjourned without a date set for re-adjournment "in sine die".
