**ORDER**

To correct and refine through Additions and Deletions and then Return for the Assembly's Ratification a NOTICE AND DEMAND From the People of Texas To Certain State of Texas Public Officials in all the Branches of its Government in the Matter of The Reserved Powers of the People of Texas.

**COMPLETION OF WORK AND RETURN TO AD HOC ASSEMBLY**

The Committee of the Whole adjourned July 3<sup>rd</sup>, 2014 after approving the text of the NOTICE AND DEMAND that accompanies this letter as Exhibit I. It included the order to the chairmen to hereby return the NOTICE AND DEMAND to the Clerk so that the Clerk could schedule the third reading for engrossment.

Many additions, modifications and deletions were made, as well as, reorganizing of the sections both for style and clarity, and the Committee of the Whole returns Exhibit I without any objection. Any such changes were made under proper parliamentary procedure and were approved after discussion was exhausted.

**HISTORY**

After the entering to the Clerk of a *Motion to Leave the NOTICE AND DEMAND* by Texian jural society participants from Cherokee County a call went out from the Clerk for the jural society participants to convene a TEXIAN JURAL SOCIETY AD HOC

ASSEMBLY for the purpose of acting on the Cherokee County *Motion to Leave*. The Clerk set the time at 8:00 pm CDT, May 1, 2014, and the place at www.freeconferencing.com, telephone number 712-412-0900, access code 103326, for the first reading process to be undertaken. The TEXIAN JURAL SOCIETY AD HOC ASSEMBLY convened at the scheduled time and place. According to rule, upon the first reading the participants can reject the motion to leave, or by passing, place it on the table for a second reading on a future date.

A motion to place the Cherokee County NOTICE AND DEMAND on the table for a second reading carried and was scheduled for May 8, 2014, at 8:00 pm CDT using the same free conferencing venue. On that date after the second reading in the Texian jural society Ad Hoc Assembly, a *Motion to Commit to the Committee of the Whole* unanimously carried.

The work of the committee began the same evening.
