Summer Program Agreement

1. As of _____, my child, _____, will be enrolled in the Summer Program.
2. I agree to pay registration fees as follows:
 - a. If my child is new to the center, I agree to pay the \$50.00 initial registration fee.
 - b. If my child is returning only for the summer program, I agree to pay the re-registration fee of \$30.00.
 - c. If my child is continuously enrolled, there is no additional registration for the summer program.
3. The Summer Program fee for my child is \$200/week, which includes the combined tuition and activity fees for the week. There is no fee reduction if children do not participate in the activity.
4. I understand that the first and last week of tuition/activity fee is due before the Summer Program begins.
5. I understand that I must indicate below which weeks that my child will be attending.
6. I understand that my child's attendance is expected for the weeks indicated and he may not be admitted for weeks that are not indicated below.
7. I understand that the center is closed on July 4, 2017, and August 18, 2017. I understand that tuition will not be reduced for weeks #3 and #9.
8. We will provide care during the week of September 4-8, 2017, for staggered Kindergarten care at the regular school age full time rate of \$170.00.
