

ORDINANCE NO. 2016-25

**AN ORDINANCE
AMENDING COMPENSATION FOR THE EMPLOYEES OF
THE VILLAGE OF HUNTING VALLEY, REPEALING
CERTAIN ORDINANCES, AND DECLARING AN
EMERGENCY.**

WHEREAS, this Council has the authority to amend the compensation of the Village's public officials and employees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF HUNTING VALLEY, STATE OF OHIO:

SECTION 1. That all elected officials shall serve without compensation.

SECTION 2. That, effective December 26, 2016, the following compensation is established for appointed employees of the Village:

Building Inspector/Service Director	\$ 9,871	per month
Assistant Finance Director	\$ 8,333	per month
Administrative Assistant, Full-Time	\$ 3,758	per month
Deputy Finance Director	\$ 500	per pay period
Electrical Inspector, Part-Time	\$ 56.19	per hour
Administrative Assistant, Part-Time	\$ 19.00	per hour
Clerk, Part-Time, Second Grade	\$ 13.00	per hour
Clerk, Part-Time, Third Grade	\$ 11.50	per hour
Clerk, Probationary	\$ 10.00	per hour
Receptionist, Part-Time	\$ 8.80	per hour

SECTION 3. That effective December 26, 2016, the following compensation is established for the members of the Police Department of the Village:

Chief of Police	\$ 10,000	per month
Lieutenant	\$ 7,770	per month
Sergeants	\$ 6,903	per month
Police Officer, First Grade	\$ 6,140	per month
Police Officer, Second Grade	\$ 5,742	per month
Police Officer, Third Grade	\$ 5,444	per month
Police Officer, Probationary	\$ 5,068	per month
Investigator	\$ 40.81	per hour
Police Officer, Part-Time	\$ 31.22	per hour
Receptionist/Clerks, Part-Time	\$ 8.80	per hour

SECTION 4. That the following compensation is hereby established for the members of the Service Department of the Village:

Supervisor	\$ 6,257	per month
Chief Mechanic	\$ 5,825	per month
Laborer/Drivers:		
First Grade	\$ 5,393	per month
Second Grade	\$ 4,980	per month
Third Grade	\$ 4,613	per month
Fourth Grade	\$ 4,262	per month
Seasonal Laborers	(range) between \$8.00 and \$24.72 per hour	

SECTION 5. That Ordinance No. 2016-9 and any and all other ordinances or parts thereof in conflict with this Ordinance be and the same hereby are repealed.

SECTION 6. That the following additional amounts shall be paid to the following employees in December of 2016:

Building Inspector/Service Director	\$ 2,000
Chief of Police	\$ 1,333
Administrative Assistant, Full-Time	\$ 1,000

SECTION 7. That the following additional amount shall be paid to the following employee in January of 2017:


Assistant Finance Director	\$ 5,000

SECTION 8. That the actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all requirements.

SECTION 9. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Hunting Valley and, further, provides for the usual daily operation of a municipal department; wherefore, this Ordinance shall be in full force and effect from and after its adoption, and the adjustment of the pay of the Deputy Finance Director shall be effective December 14, 2016.
