

**ORDINANCE NO. 2018-17**

**AN ORDINANCE  
AMENDING COMPENSATION FOR THE EMPLOYEES OF THE  
VILLAGE OF HUNTING VALLEY, REPEALING CERTAIN  
ORDINANCES, AND DECLARING AN EMERGENCY.**

WHEREAS, this Council has the authority to amend the compensation of the Village's public officials and employees.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF HUNTING VALLEY, STATE OF OHIO:**

SECTION 1. That all elected officials shall serve without compensation.

SECTION 2. That, effective December 24, 2018, the following compensation is established for appointed employees of the Village:

Building Inspector/Service Director	\$10,463	per month
Assistant Finance Director	\$ 8,687	per month
Administrative Assistant, Full-Time	\$ 4,134	per month
Administrative Assistant, Part-Time	\$ 20.44	per hour

SECTION 3. That effective December 24, 2018, the following compensation is established for the members of the Police Department of the Village:

Chief of Police	\$ 10,000	per month
Lieutenant	\$ 7,925	per month
Sergeants	\$ 7,195	per month
Police Officer, First Grade	\$ 6,401	per month
Police Officer, Second Grade	\$ 5,986	per month
Police Officer, Third Grade	\$ 5,655	per month
Police Officer, Probationary	\$ 5,283	per month
Police Officer, Part-Time	\$ 31.53	per hour

SECTION 4. That effective December 24, 2018 the following compensation is hereby established for the members of the Service Department of the Village:

Supervisor	\$ 6,522	per month
Chief Mechanic	\$ 6,073	per month
Laborer/Drivers:		
First Grade	\$ 5,622	per month
Second Grade	\$ 5,192	per month
Third Grade	\$ 4,809	per month
Fourth Grade	\$ 4,443	per month
Seasonal Laborers	(range) between \$8.00 and \$24.72 per hour	

SECTION 5. That Ordinance No. 2017-14 and any and all other ordinances or parts thereof in conflict with this Ordinance be and the same hereby are repealed.

SECTION 6. That the following additional amount shall be paid to the following employee in 2019, in equal monthly installments through 2019.

Police Chief/Village Administrator



SECTION 7. That, in January 2019, \$3,000 shall be paid to the Chief of Police.


SECTION 8. That the actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all requirements.

SECTION 9. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Hunting Valley and, further, provides for the usual daily operation of a municipal department; wherefore, this Ordinance shall be in full force and effect from and after its adoption.
