## GMAA Inc - ABRIDGED MEMBERSHIP RULES

- The classes of membership are:
  - (a) Full membership shall be available to graduates with a MBA or higher business administration qualification from programs approved by the National Executive Committee;
  - (b) Full membership shall be available to staff employed by programs approved by the National Executive Committee who do not have an MBA but who have a PhD qualification relevant to management and have taught for 2 or more years in an MBA program; and
  - (c) Student membership shall be available to students enrolled in courses of study that on completion will entitle them to apply for membership as a full, associate or affiliate member.
  - (d) Friends membership shall be available to individual persons who are not otherwise qualified for membership but who play a significant role in the area of graduate management, education and employment in Australia when the National Executive Committee believes that such membership will benefit the Association.
  - (e) Fellow membership shall be available to individual members who have obtained a DBA or PhD in management.
  - (f) Fellow membership may be granted by the National Executive Committee to an individual that has earned Fellow status by service to the GMAA.
  - (g) Fellow membership may be granted by the National Executive Committee on an honorary basis to an individual that has earned Fellow status by service to business in Australia.
  - (h) Associate membership shall be available to graduates with an MBA from a program that is not approved by the National Executive Committee.
  - (i) Affiliate membership shall be available to graduates with management qualifications other than a MBA, DBA, or PhD in management.
  - (j) Corporate membership shall be available to Graduate Business Schools, Alumni organisations of Graduate Business Schools or corporations.
- The National Executive Committee will review and approve programs providing an MBA or higher business qualification for the purpose of eligibility for membership under rule 5(a) - (c), (e), (h) and (i).
- An application by a person for fellow, full, associate, affiliate, friends, student or corporate membership shall be:
  - (1) made by the applicant either individually or shall be proposed by one and seconded by another member to both of whom the applicant shall be personally known, in writing on the Application Form and accompanied by the prescribed documents and fees; and
  - (2) lodged at the address stated in the Application Form.
- The State Chapter or National Executive Committee shall determine whether to approve or reject the application based on the criteria established by the Committee. The Committee is not required to give any reason for the rejection of an application.
- On approval of the application and receipt of payment, the applicant will be registered as a fellow, full, associate, affiliate, friends, student or corporate member of the GMAA.
- An application for conversion from student to full membership shall be conditional upon the student graduating with an MBA or higher qualification in business administration accompanied by the documents and fees prescribed in the Application Form.
- Cessation of Membership  
A person ceases to be a member of the National Association if the person:
  - (a) dies;
  - (b) resigns that membership; or
  - (c) is expelled from the National Association;
  - (d) being a financial student member and fails to convert to full, associate or affiliate membership within six months of graduating with an MBA or higher business qualification; or
  - (e) is a fellow, full, associate, affiliate, friends, student or corporate member and fails to pay the annual subscription fee for five consecutive years as and when due.
- Membership Entitlements not Transferable  
A right, privilege or obligation which a person has by reason of being a member of the GMAA Inc is not capable of being transferred or transmitted to another person; and terminates upon cessation of the persons' membership.
- Fees, subscriptions, etc.  
A member shall pay such fees as determined by the National Executive Committee.
- The liability of a member to contribute towards the payment of the debts and liabilities of the GMAA Inc or the costs, charges and expenses of the winding up of the GMAA Inc is limited to the amount if any, unpaid by the member (Rule 12(a)).
