

Cavalier Choir Trip to New York

March 13-18, 2019

The Choir Director must have this commitment contract from each student wishing to participate in order to reserve the appropriate number of hotel rooms, tickets, buses, etc. Turning in a deposit IS ALSO acknowledgement of and agreement with this contract

- Once reserved, TWCP Choir must pay for every service requested. Monies collected from students are **non-refundable** once the deposit/payment process begins regardless of a student's ability to attend for any reason. This includes CISD extra-curricular eligibility policies, illness, family schedule conflicts and tardiness for our departure.
- Once a deposit has been made, the student is responsible for **paying the entire amount of the trip** or finding another student/ parent to take his or her place in the event that he or she cannot attend the trip.
- A student will not be allowed to sign-up for the trip after the deposit payment deadline. Please check the calendar for conflicts and discuss the financial commitment before returning this contract with the initial deposit.
- **If any payment is not made by 5 days after the deadline, the student will be dropped from the trip. The deposit WILL NOT be refunded. Any refund will be at the discretion of the choir director based on the contract with the tour company**

I/we have read the above information and discussed it with my child/parent(s). I understand that upon returning this contract along with my initial deposit that services and equipment are being reserved for me/my child and that I will be expected to have the amount due in my account throughout the non-refundable payment process.

I/we understand that CISD and TWCP policies and procedures are in effect when traveling. Failure to follow these guidelines or comply with directions can result in removal from the trip at the expense of the family.

*In the event that a student cannot travel **for any reason**, I/we understand that an attempt will be made to sell that spot to another student. If it cannot be sold, I/we understand that all payments are **non-refundable** regardless of the student's ability to travel and that I/we are responsible for paying the balance of the trip.*

As a parent or guardian of this choir member, I understand the attendance requirements and conditions as described in this contract and hereby give my child permission to attend this trip.
