

**PETITION TO TEMPORARILY VACATE AND
RELOCATE A CITY ROADWAY**

TO: Mayor and City Council of the City of La Salle, La Salle County, Illinois.

The undersigned, ILLINOIS CEMENT COMPANY LLC, ("Petitioner") being the owner of the property described in Exhibit A, said property being contiguous to and on both sides of the dedicated roadway herein described hereby petitions the Mayor and City Council of the City of La Salle, La Salle County, Illinois to vacate the roadway described as follows, to-wit:

That portion of East 3rd Road from the North line of Southwest Quarter of Section 27 and the Southeast Quarter of Section 28, to a point 1690 feet South of the North line of the Northeast Quarter of Section 33 and the Northwest Quarter of Section 34 all in Township 34 North, Range 1 East of the Third Principal Meridian.

We request that said vacation be temporary and subject to your Petitioner constructing and maintaining a relocated road ("Relocated Road") to be constructed within Section 28, Township 34 North Range 1 East of the Third Principal Meridian to such quality and to the specifications satisfactory to the City of La Salle and pursuant to a separate agreement to be entered into between the City of La Salle and the Petitioner. Such Relocated Road shall remain until such time as all of the limestone has been mined in the current location of East 3rd Road and with the further agreement that the Petitioner will reconstruct East 3rd Road in its approximate present location to the plans and specifications mutually agreeable between the City of La Salle and the Petitioner.

The Petitioner assures that it is in the best interest of the municipality and for the common good that the City agree to the temporary vacation of the roadway described herein and a plan incorporated into writing for the construction and maintenance of the Relocated Road and the reconstruction of East 3rd Road.

EXHIBIT A

Parcel 1 (West of East 3rd Road)

Tract I (Mora) 11-28-404-000

That part of the North Half to the Southeast Quarter of Section 28 in Township 34 North, Range 1, East of the Third Principal Meridian, described as follows:

Commencing at the Northwest corner of the Southeast Quarter of said Section 28, thence due South along the East line of the Southeast Quarter of said Section 28, for a distance of 964.69 feet to the point of beginning, continuing thence due South along the East line of the Southeast Quarter of said Section 28 for a distance of 195.00 feet, thence South 88 degrees, 57 minutes 30 seconds West for a distance of 136.00 feet, thence due North for a distance of 195.00 feet, thence North 88 degrees 57 minutes 30 seconds East for a distance of 136.00 feet to the point of beginning, situated in LaSalle County, Illinois.

Tract II (Ferguson) 11-28-406-000

That part of the North One Half of the Southeast Quarter of Section 28, Township 34 North, Range 1 East of the Third Principal Meridian, except the South 10 acres thereof and excepting therefrom the Right-of-Way of the Illinois Central Railroad Company, and the South 10 acres of the Northeast Quarter of Section 28, excepting therefrom the Right-of-Way of the Illinois Central Railroad Company, described as follows:

Commencing at the Northeast Corner of the Southeast Quarter of said Section 28, thence South 00 degrees 00 minutes 00 seconds East 835.77 feet along the East Line of said Southeast Quarter to the Point of Beginning, thence continuing South 00 degrees 00 minutes 00 seconds East 128.92 feet along said East line, thence South 88 degrees 57 minutes 30 seconds West 136.00 feet, thence South 00 degrees 00 minutes 00 seconds East 195.00 feet, thence South 88 degrees 57 minutes 30 seconds West 101.50 feet; thence North 00 degrees 02 minutes 33 seconds East 326.66 feet, thence North 89 degrees 37 minutes 07 seconds East 237.22 feet to the Point of Beginning, said tract containing 1.164 acres, more or less.

Tract III – 11-28-401-000 & 11-28-402-000

Southeast Quarter of Section 28 North, Range 1 East of the Third Principal Meridian all situated in the County of LaSalle and State of Illinois.

Tract IV – 11-28-405-000

The South 10 acres of the Northeast Quarter of Section 28, Township 34 North, Range 1 East of the Third Principal Meridian all situated in the County of LaSalle and State of Illinois.

Tract V – 11-33-200-000

The North 100 acres of the Northeast Quarter of Section 33, Township 34 North, Range 1 East of the Third Principal Meridian, except the former Illinois Central Railroad all situated in the County of LaSalle and State of Illinois.

Parcel 2 (East of East 3rd Road)

Tract I – 11-27-300-000

The Southwest Quarter of Section 27, Township 34 North, Range 1 East of the Third Principal Meridian all situated in the County of LaSalle and State of Illinois.

Tract II – 11-34-100-000

The Northwest Quarter of Section 34, Township 34 North, Range 1 East of the Third Principal Meridian all situated in LaSalle County, Illinois.
