You may think you're just a drop
in the ocean, but look at the
ripple effect one drop can make!

“How is God calling me?”

Decisions, decisions, decisions... since the beginning, God has asked us to take heed of our decisions. Because our life can be significantly altered by the paths we chose, we worry a lot about decisions, but we do have an ally always with us... God. “We all make decisions constantly, some with careful reflection, many offhandedly and without much thought. What if we understood these decisions, minor as well as major, as a matter of faithful Christian living, ...to come closer to God in all our actions, in all our decisions, and in everything we do?” asks **Sister Elizabeth Liebert** (Sister Beth).



Sister Beth, who teaches spirituality at San Francisco Theological Seminary, has done much research and reflection on the subject. Her book, *The Way of Discernment, Spiritual Practices for Decision Making*,

“Discernment is a way we reflect on our lives before God. ...discernment helps us bring ourselves back to the questions, ‘why are we here?’ and ‘where are we going?’”

is a great guide to the practice of discernment (faithful decision making). It offers exercises such as the use of reason, intuition, emotion, and imagination, that can help you see where God is already at work in your life and allows you the freedom to become increasingly generous with your life in response.

In the fall of 2013, as a resident scholar at the Collegeville Institute, she continued her exploration of the art and practice of Christian discernment. She shares her insights in a video interview. Contemplating a Global Sorority

Sister Sophia Park is Assistant Professor of Religious Studies and Philosophy at Holy Names University. She is also a contributor to the Global Sisters Report website—a project of the National Catholic Reporter. As well as reporting on the news, the Global Sisters Report is an excellent venue for Sisters to share their thoughts and reflections with other Religious communities around the world. In August, Sister Sophia wrote an article for the “Contemplate This” column reflecting on this new global sorority.

Sister Sophia pointed out that there are challenges that come with cultural differences, that need to be

acknowledged. An example of this: American Sisters tend to jump quickly into dialogue, which can be intimidating to those from cultures that do



not encourage expressing opinions. Remembering to slow down, relax our minds and our vision and look with “a long and loving look,” can help lessen the differences.

The one common affinity in global sorority is prayer, “when we pray together, I feel a sisterhood deeper than at any other time...I experience being together and an embracing of the globe.”

A truly global individual herself, Sister Sophia was who the National Catholic Reporter turned to when they wanted a South Korean native’s view on Catholicism in South Korea before Pope Francis’ visit. Opportunities as deep as the ocean at Villa Maria del Mar

In Santa Cruz, the Sisters at Villa Maria del Mar have been praying for new ways to share their wonderful home and enhance its spiritual ministries.

Sister Molly Neville offered to help reach out to see if there was any interest in organized Spiritual Direction opportunities. Sister Molly wrote to pastors, catechists, and other parish and Catholic school leaders, about the possibility; and in her conversations with them, learned that there was strong interest. She organized a group of SNJM and other spiritual directors to offer spiritual accompaniment on Wednesdays and some Saturdays.

When Bishop Garcia from the Diocese of Monterey read Sister Molly's announcement, he asked her to consider helping arrange spiritual direction for the Permanent Deacon Candidates and their wives. Sister Molly will also arrange in-service opportunities at the Villa for spiritual directors (lay, priests and religious) in the diocese. They plan for an Intensive in-service week for May 2015 that will focus on the integration of active listening skills, prayer development, and the art of discernment. The Villa is so pleased to be able to support all the facets of this new transformational effort!

Looking inside the Villa, other opportunities came to light. **Sister Guadalupe Guajardo** will offer a charism and team-building workshop to Villa staff, in both Spanish and English. While she was at the Villa for the "After 70" retreat, Sister Guadalupe spoke with the staff to learn of their interest in knowing more about the SNJM charism. She is planning to offer the charism day in December with the help of **Sister Cecilia Calva**.

The staff, whose primary language is Spanish, also said that they were interested in improving their English-language skills. **Sister Miriam Daniel Fahey** came



over to the Villa in September to visit any Spanish-speaking staff member interested in assessing his/her English-language skills. Most volunteered for this opportunity and Sister Miriam Daniel gave them ways that they could continue to work on their English. The staff is so grateful for her kindness and perceptiveness!

There is nothing better than listening to the sound of the ocean, except perhaps, listening to music by the ocean. A member of the Chapel community offered the Villa a gift to engage musicians for some weekend liturgies. Starting in October, the Chapel will have a cantor with a guitarist or **Sister Elizabeth Adams** (Sister Liz) accompanying for two weekend liturgies a month. Sister Liz said that she was happy to help with the liturgy and the monthly Taize prayer, but she could really use a piano. Prayers were answered when a local parishioner offered a spinet, and another offered to move it to the Chapel! The Sisters and volunteers are excited that their liturgies are becoming livelier, and are so grateful to the donors and to Sister Liz for making this possible. Please pray that these opportunities for spiritual growth will flow out to the faith community of our rural mission diocese.

Prayer, discernment, and dialogue finalize completion of Los Gatos long range plan

We are pleased to share with you that we have successfully completed our Los Gatos long range planning and transition from the Convent of the Holy Names. Our aging Sisters have successfully transitioned to two quality housing and care communities: Our Lady of Fatima Villa, in Saratoga, California, sponsored by the Kenosha Dominican Sisters, and Merrill Gardens Retirement Community in Campbell, California. We also have purchased a small church property situated right next to Merrill Gardens, which consists of a chapel, offices for support services and a residence.

Over the past year and a half, we have collaborated with the Town of Los Gatos and our neighbors to return the Los Gatos property to its residential roots. The Town of Los Gatos unanimously approved our 17 home subdivision plan in March of this year. We are pleased to announce the sale of the property to Palo Alto-based SummerHill Homes on August 26, 2014.

The proceeds from the sale of the Los Gatos property represent critical funds necessary for future health care and housing needs of our aging members. Many of you have supported your own family members as they aged and know the costs and challenges entailed in doing this well.

Thank *you* for the many ways you have been and continue to be supportive of our community mission. We have appreciated the concern, support and prayers that we have experienced from so many of you throughout

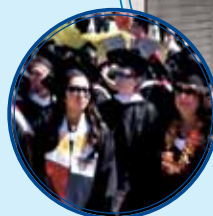

In this circumstance, we invite you to consider making a gift for the future. If you are in the process of updating or beginning to prepare your will, or reviewing your financial portfolio, it may be beneficial for you to consider the following ways of making a charitable gift to the Sisters of the Holy Names.

Bequests

Remembering the Sisters in your will is one of the easiest planned gifts you can make. You can first specifically provide for family and friends, and then leave a percentage or specific amount to the Sisters of the Holy Names. In so doing, it is important to use the legal title of the Congregation: Sisters of the Holy Names of Jesus and Mary.

Please notify us when you chose to include the Sisters in your will so we may recognize you as a member of the Marie Rose Legacy Society. Your membership in the Marie Rose Legacy Society allows us to thank you and recognize you for the plans you have made. Our legacy Society members and their intentions are remembered in the daily prayers of the Sisters and at a Mass offered specially for them. Another important benefit you will receive from joining the legacy Society is the satisfaction derived from making a lasting contribution to the Sisters of the Holy Names and their long-term strength.

Name a Beneficiary

Naming the Sisters as a beneficiary of your retirement plan, insurance policy or financial account is simple and has lasting effects.

Life Income Gifts

Make a gift to assure future support of the Sisters and retain income for your lifetime.

Retirement Plan Gifts

Assets accumulated in a retirement plan, such as an IRA, can be a source of funding for a charitable gift. The current IRA rollover rules allow individuals ages 70 or older to transfer funds of up to \$100,000 tax-free to a charitable organization.* The Sisters of the Holy Names of Jesus and Mary may also be named as a beneficiary or contingent beneficiary of such plans.

One of the primary benefits of designating a charity as your IRA beneficiary is that your assets are not taxed as they pass to your beneficiary upon death. If you designate an individual, that person is subject to ordinary income tax on withdrawals from the IRA, which begin immediately upon transfer. Passing those assets to a charity rather than to an individual could save thousands of dollars in assets. Tax benefits are based on IRS regulations at the time of the designation.

If you are considering a deferred gift, please let us know so that we can assist you and your advisors in creating your individualized giving opportunity.

** To date, the IRA Charitable Rollover extension has not been approved for 2014, but there is optimism that it will pass in late November or early December. Contact your financial advisor before year end to find out.*
