


#### Three Rivers Park District Foundation Financials

#### **EXPLORER CAMPS**

In the summer of 2016, your donations provided \$25,000 to help launch Explorer Camps, which reach kids and families who are often unable to attend Three Rivers programs because of income or transportation issues. Working directly with first tier cities and non-profit organizations, park staff designed a full summer of camps to introduce participants to outdoor activities like birding, archery, biking, pond study, fishing, insects, and tree studies. Each camp took place in a local community park and included a field trip to a Three Rivers park.



#### PARKS ON THE GO VAN

In its second successful year, the Parks on the Go van donated by the Foundation through your generosity, brought outdoor recreation and nature fun to over 18,000 people in the region, serving primarily inner tier suburbs that have less access to the Three Rivers system. The van and staff visited over 220 events including summer festivals, city day camps, playground programs, farmers markets and cultural events.



#### SUMMERBRATION@THE FARM

Last July we held our fundraiser at Gale Woods Farm, and thanks to you we raised over \$8000 to help fund Explorer Camps, Adaptive programs & school outreach. The stormy weather cleared and the fun kicked in to high gear with farm fresh food, beer, wine, bluegrass music, tours, and a wonderful silent auction.
