

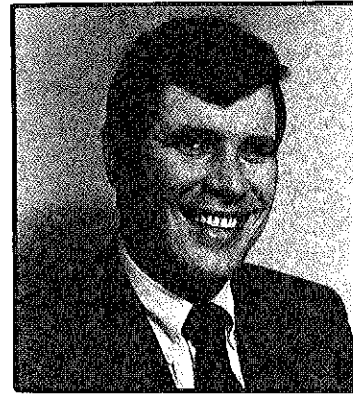
# Professional Development Committees A Unique Resource and Opportunity
