CHAPTER ELECTION

NTEU Chapter 67 June 5, 2017- June 1, 2020

In accordance with Part IV of the NTEU Bylaws, this is the Official Notice for Nominations and Election of Officers for Chapter 67. Chapter 67 will hold a secret ballot election on June 3, 2017 for the following offices: Chapter President, 1st Vice President, 2nd Vice President, Treasurer and Secretary.

The term of the above offices is 3 years, commencing on **June 5, 2017** and ending on **June 1, 2020**. The elected President and Vice President[s], who are elected at-large shall serve as delegates to the National Convention.

Any member wishing to nominate a candidate for the **aforementioned** offices must submit his/her nominations in writing (using the form at the end of this notice or a photocopy thereof) only by U.S. Mail. Nominations must be **received** by the Chair of the Election Committee at: **NTEU Chapter 67 Election**, **PO Box 13390**, **221 N Washington Blvd**, **Ogden**, **UT 84412** by **5pm MT** on **April 7**, **2017**. Nominations by phone or personally delivered will **not** be accepted.

Any member nominating a candidate, including him/herself must identify him/herself. Only those members who joined Chapter 67 on or before **March 3, 2017** are eligible to nominate candidates and vote in this election.

Self-nomination is permitted.

All candidates must be a member in good standing of Chapter 67 as of March 3, 2017

Any member of this Chapter (except an employee who under the provisions of the Civil Service Reform Act of 1978 is considered a supervisor and, therefore, ineligible to participate or represent this Chapter as an officer) may be elected to any office. The Election Committee will notify all candidates in writing of their nomination.

Each nominee, except those who are self-nominated, must submit a written acceptance to run for office (using the attached Acceptance Form or a photocopy) to the Chair to be **received at PO Box 13390, 221 N Washington Blvd Ogden, UT 84412** no later than **5pm MT April 21, 2017** or via personal (<u>not</u> government) email by the same time **5pm MT on April 21, 2017** to **NTEU67Election@gmail.com**. An individual may run for only **one** office and, if nominated for multiple offices, a nominee may accept for only **one**. If a candidate is unopposed, there shall be no necessity for the election of such nominee and he/she shall be declared duly elected.

THE ELECTION

The Election will be conducted by mail referendum ballot on **June 2, 2017.** Write-in candidate are not allowed. Candidates or one appointed observer may be present at all phases of the election.

Ballots will be mailed on May 1, 2017.

Members who do not receive a ballot before May 12, 2017 should make a request for a <u>duplicate</u> ballot to the Chair at the email address NTEU67Election@gmail.com or call 801-317-7213.

Members who will not be at their current address during the Election should make requests for <u>absentee</u> ballots to the Chair at the email address NTEU67Election@gmail.com or call 801-317-7213.

Ballots must be <u>received</u> by June 3, 2017 at 11:00am MT at PO Box 13390, 221 N Washington Blvd, Ogden, UT 84412 and will be picked up at that time from the Ben Lomond Ogden post office. The ballots will then be tallied at Comfort Suites located at 2250 S 1200 W Ogden, UT 84401 in the 'Boardroom' beginning June 3, 2017 at 12pm MT (Noon). The candidate receiving a plurality of votes for each particular office shall be declared the winner.
