Terms and Conditions for Using University of New Brunswick Computing Facilities While Attending Worlds UNBound/L'Univers sans limites Summer Camp

Junior Counsellors and Parents or Legal Guardians are required to read and sign this document together!

The internet is a wondrous place. During their week at Worlds UNBound, participants may be invited to surf the net to discover its content and fascinating issues. However, with access to computers and people all over the world comes the availability of material that may not be considered appropriate in a youth camp setting. Worlds UNBound/L'Univers sans limites has taken the precautions to restrict access to controversial materials.

However, it is impossible to control all the material that is not consistent with the educational goals of our summer camp. Worlds UNBound/L'Univers sans limites has therefore enacted a policy restricting participants accessing questionable material during their week at camp. The following violations will lead to the disciplinary actions of a parental phone call and the possible removal from the Worlds UNBound/L'Univers sans limites summer camp without monetary reimbursement:

- Viewing or participating in any illegal activities
- Viewing material deemed inappropriate by Worlds UNBound staff
- Harassing other users with unwanted e-mail messages
- Failure to comply with University of New Brunswick guidelines
- Vandalism of accounts and systems
- Using abusive, vulgar, and otherwise inappropriate language

- Creation and publication of inappropriate material
- Sharing of individual and networked accounts and passwords

Agreement to Comply

As the parent or guardian of the above named child, I have read and understand the terms and conditions of this agreement. I have discussed the agreement with my child and we both acknowledge the consequences in understanding that if he/she fails to comply with the terms and conditions, he/she may be removed from the Worlds UNBound/L'Univers sans limites summer camp. Worlds UNBound/L'Univers sans limites has taken precautions to restrict access to all controversial materials and I will not hold them responsible for materials acquired on the network.

Health and Behaviour Waiver

I understand that Worlds UNBound/L'Univers sans limites holds a zero tolerance policy for violent, disruptive, or other behaviour that prohibits the learning and safety of all participants, including my own child. Such behaviours can result in children being immediately sent home at the discretion of the camp director. I agree with this statement and I am willing to retrieve my child from camp if a situation like this were to arise.

If an incident were to arise where my child needs medical attention, I give permission for a First Aid certified instructor to administer First Aid or to take my child to the hospital if I cannot be reached.
