



Mission Trip Contract

I desire to participate in a Red Page Ministries mission trip and in doing so, I agree to the following:

- If I am able to participate in the mission trip, I will be responsible for paying the total trip cost, including land and airfare, established by Red Page. I realize that all checks should be made payable to "Red Page Ministries" and mailed to P.O. Box 53653, Lubbock, TX 79453 or that I can pay online via www.redpageministries.org. I understand that by choosing to pay online a 2% convenience charge will be added to my trip cost. I also understand that upon submission of my \$200 non-refundable deposit, an account will be established and all monies will be administered as a personal "support account" set up in my name on the books of Red Page. I will also submit:
 - My airfare cost by the due date listed on the Red Page website; and
 - All remaining mission trip costs by the due date listed on the website.
- In the event that mission trip funds raised exceed mission trip costs I understand that I may:
 - Request such funds be applied as a non-refundable deposit toward a future Red Page mission trip during the next 18 months. No interest will accrue for funds left in the account. At the end of 18 months, any remaining amount in my account will become the property of Red Page, and all records of my account may be discarded.
 - Request such funds be applied to another trip participant or intern's account for their use for a future Red Page mission trip or internship within the next 18 months. No interest will accrue for funds left in the account. At the end of 18 months, any remaining amount in my account will become the property of Red Page, and all records of my account may be discarded.
 - Request such funds be applied to a specified Red Page program for immediate use.
 - Request such funds be used at the sole discretion of Red Page immediately.
- In the event that I do not participate in the mission trip for any reason, any charges incurred on my behalf, including without limitation airline cancellation fees and deposits, will be deducted from my account, and I will be responsible for any deficit. I will pay any deficit within fifteen (15) days following notice to me of the amount of such deficit.
- A charitable contribution to Red Page designated to my personal support account is a gift to Red Page Ministries. Gifts to Red Page become the sole property of Red Page. A gift to Red Page is a charitable contribution for federal income tax purposes to the extent permitted by law. Tax deductible gifts cannot be refunded. In the event I do not participate in the mission trip, gifts to Red Page will go to support Red Page ministry costs.

In addition, I agree to the following regarding my behavior:

- Treat all other persons with respect and not cause any intentional harm (physically, emotionally, or spiritually) to any person in any way.
- Respect the property of others, including all program facilities and property.
- Follow all appropriate instructions of all personnel aiding in this event, including but not limited to, Red Page staff and trip leaders, support staff, transportation personnel and administration.
- Be on time for all check-ins and departure time.
- Not have in my possession any tobacco, alcohol, or any controlled illegal substance.

I recognize that not adhering to the above behavioral code could result in my immediate return from the mission field at my cost.

I agree that any claim or dispute arising from or related to this Mission Trip Contract or any mission trip in which I participate shall be governed by Texas law and applicable laws of the United States. The venue for resolving such disputes shall be Lubbock, Texas.
