## President's Report to the 2015 Annual General Meeting on 26 May 2016

I am delighted to welcome you all to the 2016 AGM of the Cambridge Society of New South Wales, my inaugural AGM as President of the Society.

The Cambridge Society of New South Wales is a social association of Cambridge University alumni in New South Wales. We organise formal and informal social functions where members and their guests can meet fellow alumni, maintain and renew old friendships and make new ones, bonded together by their heritage of the world's finest academic and intellectual institution.

In 2015 we continued with a similar format of events as previous years; a series of "Thinking at Twilight" seminars, the Winter Feast, the Christmas Drinks, and a sprinkling of sporting events.

- The first Thinking at Twilight Seminar was held on 25 February. Alumni gathered here at the UUSC to hear committee member Chandra Senaratne speak on reincarnation.
- The second Thinking at Twilight Seminar was held on 26 March. We welcomed Professor David Yates from Robinson College who was visiting Sydney. Professor Yates is also an Adjunct Professor of Law in the University of Sydney. He talked about "What do Clients want from their Lawyers".
- The AGM was held on 21 May. Emma Brown then introduced our guest speaker for the third Thinking at Twilight, fellow alumnus Simon Blackburn who leads the Digital Practice at McKinsey. Simon spoke on how the digital revolution is reshaping business and how Australian companies should respond. A large audience was treated to a fascinating talk which was followed by insightful Q&A.
- The Annual Winter Feast was again held at the Royal Sydney Golf Club on Wednesday 2 September 2015. We were delighted to welcome Cambridge alumnus, The Honourable Justice Melissa Perry as our Guest Speaker. Justice Perry was appointed to the Federal Court of Australia in September 2013. Justice Perry spoke passionately about "Shattering Glass and Bamboo ceilings – Benefiting from Diversity". Guests will recall a fellow alumnus was taken ill during Justice Perry's talk. Fortunately, and as you'd expect at a Cambridge function, there were many doctors in the house and, importantly, some of the medical variety. It was truly fitting to the subject matter of the talk that the three medics who immediately came forward were all female. We are grateful to Drs Roo Robinson and Dedee Murrell and her guest Sharleen Hill for tending to the emergency. I am pleased to say our affected guest was discharged from hospital, fully fit, a few days later.

## Financials

Accounts are available from the Administrator, Suzie Ruse. Paid up membership numbers in 2015 reached 138 members. We again finished the 2015 year in reasonable financial shape. At the beginning of the year the cash on hand was \$21,076.15. At the end of the year the cash balance was \$19,590 a decrease of \$1,485.

The financial principles of the Society are to break-even on functions and cover the fixed costs by membership fees. For the last six years we have asked members to give the Committee the right to increase the annual fees \$5 to \$45. And each year the Committee has decided to keep the membership at \$40. Again we are going ask that the Committee have the right to increase fees for 2017 by \$5 or \$10 to \$50. The Committee is not saying it will increase fees but it believes it must continue to have the flexibility.

On the administrative front, Suzie Ruse, continues to do a great job in her role of administrator. My personal thanks and that of the Committee go to her for all the assistance she has given me and the Society in the last year.

## Committee

Alistair Newmarch has agreed to continue as Treasurer. As Jonathan Negus is away on specialist surgical training this year the position of Secretary has been filled by Alison Ross.

Chris Dawson wishes to remain as Vice-President and the Committee has asked me to continue as President.

The rest of the Committee comprises Julie-Anne Bosich, Emma Brown, Rhiannon Chisholm, Rhys Goodey, Alex Palmer Liza Rybak, Chandra Senaratne, Sasha Shevtsova and Gautham Srivinas.

They have all indicated they wish to continue as Committee members. And may I take this opportunity to thank all the Committee members and office bearers for their efforts during 2015.
