

## **CAMSOC Winterfeast 2009**



The Speaker for the 2009 Winterfeast was Paul Brunton, Senior Curator, Mitchell Library, who spoke to a packed house at the Royal Sydney Yacht Squadron on "*Darwin in Australia and Cambridge*". 2009 was the bicentenary of Darwin's birth and 150th anniversary of the first publication of *The Origin of Species*. The picture above was the one of the last photographs taken of Charles Darwin, circa 1878. Paul was the curator for the excellent Darwin Down Under exhibition at the State Library. In the picture above he is shown with final, handwritten journal of Pringle Stokes, the first captain of HMS Beagle. Had Stokes not committed suicide, Charles Darwin would never have been invited to join the Beagle on its epic second voyage. Paul spoke brilliantly for over 45 minutes, explaining why scholars now think that Darwin's visit to Australia in 1836 was a seminal event in the development of the theory of evolution and on Darwin's life. During a 30 minute question time his witty replies to questions kept the audience in great humour. It was a terrific night and the positive feedback was wonderful.




Cambridge has been the scene of famous murders that gripped not just the town but the whole nation, ranging from to the unsolved murder of Cambridge shopkeeper Alice Lawton to the murder of a 15-year-old drummer boy whose ghost haunted the killer and drove him to confess. Cambridge has also been the setting for various detective novels such as the Matthew Bartholomew mediaeval mysteries by Susanna Gregory. The world's greatest detective, Sherlock Holmes, before moving to 221B Baker Street, attended Sidney Sussex College in the early 1870s.

Professor Barry Maitland grew up in London after his family moved there from Paisley in Scotland where he was born. He studied architecture at Trinity College and went on to work as an architect in the UK, then took a PhD in urban design at the University of Sheffield, where he also taught and wrote a number of books on architecture and urban design. In 1984 he moved to Australia to head the architecture school at the University of Newcastle in New South Wales, and held that position until 2000.

However it is as a writer of detective fiction that Professor Maitland has gained world-wide fame. In particular he is the author of the acclaimed Brock and Kolla series of crime mystery novels. The Brock and Kolla novels were among the first in contemporary crime fiction to feature a male-female police team as the central characters, playing complementary roles in the resolution of their cases. His novels are celebrated for their strong sense of place and atmosphere due in part to his architectural background.

One of Australia's most celebrated crime writers, a Cambridge alumnus, will be speaking on the great crimes of Cambridge and its most famous fictional detectives. You will be in one of Sydney's finest venues, eating a terrific meal, drinking great wine, and with fellow alumni. Could there be a better evening?

## *Values and objectives of the Society*

---

The Cambridge Society of New South Wales is a social association of Cambridge University alumni in New South Wales and achieves its aims through formal and informal social functions where members and their guests can meet fellow alumni, maintain and renew old friendships and make new ones, bonded together by their heritage of the world's finest academic and intellectual institution.

The financial operating objectives of the Society are simple.

1. Breakeven on functions.
2. Obtain sufficient membership fees for the year to maintain the Society and pay administration costs.

The Society has continued to attract sufficient members that administration costs have been more than adequately covered. Accordingly the Committee has decided to keep membership fees at \$40.00 and to have free drinks and nibbles for the members at the AGM.

A corollary of these objectives is that where functions are booked on a sliding cost scale, the Society must cover itself by having all the cash in hand before the function starts. People who arrive on the night with cash or cheque, without previously made a paid booking, should not expect to be able to partake as of right.

There has been no increase in membership fees for a number of years and, as inflation had returned to Australia, the 2009 AGM voted to raise membership fees by the princely sum of \$5 to \$45 for the 2009 financial year. However, given the Global Financial Crisis and the health of the Society's balance sheet, it was decided to keep membership fees at \$40 for 2010. Members should be aware that Committee membership is only allowed to Society members who are financial at the start of AGM.

## ***4-Way Debate Oxford & Cambridge vs Harvard & Yale "The older your university, the more eloquent your speech"***

Over 120 people (a packed house) attended the debate held on Wednesday 28 April, 2010 at the KPMG auditorium. Canapés were provided by KPMG and drinks were supplied by Lion Nathan (CEO Rob Murray is a Cambridge alumnus). The selection of wines from the Lion Nathan portfolio were gratefully appreciated by the guests and included Wither Hills Sauvignon Blanc, Stonier Chardonnay, Knapstein Carbernet Merlot and St Hallett Shiraz.

The debate was organised by Harry Chiam (Oxford) with support from John Rothnie-Jones (Cambridge, who also runs the successful IQ2 debates). At the first organising meeting Paul Hunyor (Harvard) casually slipped into the conversation that he would get Greg O'Mahoney to represent Oxford and that the two of them had won the World Intervarsity Debating Championships. Also he could get Adam Spencer (ABC radio commentator and their debating coach) to act as "independent" judge/MC. I remember walking out of the meeting and saying to Vice-President Chris Dawson "Do you think we could get Germaine Greer?"



Who was to represent Cambridge became a matter of concern. Fortunately Committee member and Executive Search genius Charlie Kingdon suggested Rashda Rana, former London barrister and currently chief legal counsel for Bovis Lend Lease. Rashda more than held her own. Harvard/Yale chose to attack Oxbridge as elitist and argued that Harvard and Yale were more diverse. Rashda, who was born in Sri Lanka, coolly looked at the four white males sitting around her and said “On this platform, I am the diversity.” The laughter from the Asian members of the audience was only matched by the cheers of the females. At that point the debate was over and Oxbridge won on a telling show of hands.

I must also mention the contribution of Dr Peter van Onselen who stepped in at literally the last moment as Adam Spencer’s replacement. Peter is an associate professor in politics and government at Edith Cowan University, columnist at The Australian, and hosts a weekly programme "The Contrarians" on Sky News. Peter was absolutely outstanding and brought the house down on many occasions with his impromptu quips.


There could be another debate in 2011 and it is not an event to be missed.

### ***2009 CRICKET & TENNIS MATCHES***

(by John Rothnie Jones) Thanks to our sponsors, Middletons, we were again able to stage the annual Oxford/Cambridge cricket and tennis match at St. Pauls College, Sydney University. This year the weather was kind and perfect conditions greeted the arrival of Oxbridge cricketers of varying ages and skills. The pitch needed a little loving care and the Oxford captain and former Bradman scholar, Geoff Lovell and Cambridge’s Charlie Lewis shared the duties with brush and roller. And a very good job they did. A suitable surface having been established for this titanic struggle, Oxford won the toss and, not surprisingly, decided to bat.

For Cambridge, Charlie Lewis and Tom Hanson bowled outstandingly to restrict the Oxford openers to 18 off the first six overs and shortly after picked up the first wicket. Charlie went on to bowl an uninterrupted spell of 14 overs. He beat the bat regularly; and whilst not taking any wickets, it was a great effort for a 43 year old with even older knees. The Oxford innings progressed steadily but not expansively. The dangerous former Blues Nathan Ashley and Geoff

Lovell were contained and it was not until the 25<sup>th</sup> over that the score reached 100. The last ten overs, thanks to some excellent bowling from Mark Hodge (5 for 34) and Guy Stuckey-Clarke (3 for 19), and supported by some surprisingly agile ground fielding and catching, only brought a further 45 runs and Oxford were finally bowled out for 145.



Tea was taken between innings as cricketers, tennis players (under the inspired even-handedness of organiser, Gemma Easter, the tennis match was keenly contested and declared a draw) and spectators came together to tell tales of long forgotten and heavily embellished sporting prowess.

The Cambridge innings started slowly with former Blue, Dominic Katter and skipper, Rothnie-Jones being restricted by former Oxford paceman, Ben Wood, who bowled 7 overs for 16 runs. When Rothnie-Jones was bowled by another former Blue, Michael Jeh, who'd travelled from Queensland to play, in the 16<sup>th</sup> over, the situation changed markedly. Four wickets fell for the addition of as many runs. Former Blue, Russell Lyons, former Crusader, Nick Bilinsky and Guy Stuckey-Clarke picking up just one run between them. From this point, Michael Jeh (3-14) and former Authentic, John Pickhaver(4-33) made life very difficult for the Cambridge middle and lower order. Wickets fell regularly and the required rate rose accordingly. When former Rugby Blue and Cambridge committee member, Ali Newmarch was run-out, the light blues were a spent force. A final score of 111 was a disappointment after a promising start.

The day had been a great success for both the dark and light blues and, after some speeches of thanks, both sides adjourned to the local pub to construct next year's battle plans.
