Whereas, I wish to enjoy as recreation the benefits of membership in the Neenah-Nodaway Yacht Club (hereinafter, "Club"), I make the following Release of Liability and Assumption of Risk Declaration.

I declare that I know, understand, and assume all risk of loss, damage, or injury (including death) to me and my property from any cause associated with any Club activity, function, or operation. I engage the same voluntarily and in reliance upon my own judgment and abilities, not those of the Club, its officers, agents, or employees.

I understand the Club activity, function, or operations covered by this Release of Liability and Assumption of Risk Declaration include but are not limited to the following: operating, maintaining, and repairing the mooring and docking area, including providing dinghies and moving member boats; organizing and operating races; holding social events at the mooring area and elsewhere; such as other activities as are scheduled from time to time by the Club.

I agree to allow the Club to take photographs of me, my family, and/or my boat participating in club events and to publish them in any media for publicity, editorial, or advertising purposes.

Except as indicated below, I agree to have contact information for myself and my spouse published in the membership booklet and the website, for member contact purposes only. 

- Membership applications received after April 30 will be mailed within two weeks of their receipt.
- Moorings are available to Junior, Full or Life Members and are assigned after April 15th.
- Dinghy and Kayak storage is available to Junior, Associate, Full, and Life Members.
- Mooring assignments are emailed by harbor opening and indicated on membership cards.
- **Note:** Moorings are available for a limited number of catamarans or trimarans on a case-by-case basis.

CLASSES OF MEMBERSHIP

Life	Available, on the basis of a single payment, to individuals whose age is greater than 18 on May 1 st of the membership year. All Full membership privileges are provided for life.
Full	Available on an annual basis to individuals, 18 or older on May 1 st of the membership year. It includes membership for a spouse and children living in the same household. Full membership privileges are provided.
Associate	Available on an annual basis to individuals who do not wish to participate in full club activities. It includes membership for a spouse and children living in the same household. All membership privileges are provided except: you may not vote, hold office, rent club moorings, or race a keelboat, Laser, or Flying Scot in club sponsored races. Associate members may race a boat in the Dragon Force 65 Radio Controlled races.
Junior	Available on an annual basis to individuals, age 18 years and under, or full-time students under 21 on May 1 st of the membership year. All membership privileges are provided.
