5/10/2018	Cement truck with pump rack on west side of CUB.	Possibly visible.
5/21/2018 – 5/22/2018	On 5/21/18 at 2:54pm, the NM Site experienced an internal, onsite power disturbance due to a component failure. There was a severe weather event with rain, hail and heavy wind at the time of the disturbance. The factory was evacuated. During restart, the Fab 11NX thermal oxidizer system fans faulted and the units could not be restarted. The Fab 11X Fab and Bridge thermal oxidizers were offline from 2:54pm and restarted at 5:25pm and the Fab 11NX thermal oxidizers were offline at 2:54pm and restarted at 12:15am. The Sandoval County Emergency Manager, Rio Rancho dispatch supervisor and the Corrales Fire Department were notified that the Fab 11NX thermal oxidizer were offline as a result of the power disturbance and that personnel were working to restart the equipment.
