RESPONSIBILITIES OF THE OUTING COORDINATOR

To have a successful outing there can be only one (1) person who is in charge. We must be in contact with that person on an ongoing basis to insure the success of the outing. The person designated as the “outing coordinator” will be the **only** person authorized to make changes, additions and/or deletions for the group. As coordinator the responsibilities are as follows:

- 1) Provide the club with an accurate number of participants in accordance with the guidelines set out in the “OUTING RESERVATION AND CONTRACT.” Additions and deletions are not allowed once the final estimate has been provided.
- 2) Provide the club with a list of participants and foursomes at least 3 days prior so that we may prepare hole assignments and/or tee times in advance of the event. In addition it is best to rate your groups so that quicker groups may be placed in the front of the field.
- 3) Have the players arrive at the course at least **one-hour** before the scheduled start of the event.
- 4) Pay for the function. We will not accept functions that require the individual players to pay. The coordinator must make arrangements for payment and make payment according to the contract.
- 5) Inform and police the players with regards to club rules. **Alcohol is not allowed on the golf course.** If a player is found with alcohol on the golf course, they will be removed from the course without refund. **All players must be properly dressed.** Proper dress includes a collared golf shirt, no cut off jeans, gym shorts or bathing suits. Golf shoes or sneakers are required, no soccer shoes, running shoes or street shoes are allowed.

OUTING GUIDELINES

Thank you for your interest in Passaconaway Country Club. The following information will help you in having a successful outing. There are tasks that you, as the outing coordinator, must complete prior to the outing. Passaconaway Outing Policy

Passaconaway is available for outings seven days per week. We are prepared to handle all your requirements including food and beverage, prizes and on-course competitions. "Shot-gun" starts are available under the criteria set forth below. Rain dates are generally not available. If the golf course is closed by management a full refund is available. We will make every effort to reschedule your event if it is postponed. Rain, cold or poor weather are not causes for cancellation.

Damage Liability

The group will be responsible for any damage to the golf course and its equipment caused by players and /or volunteers of the group. The Club reserves the right to require a damage deposit for large groups.

Adherence to Course Rules

The Club reserves the right to revoke playing privileges of any individual or group who in the sole opinion of the management of the club are unable or unwilling to adhere to the club rules or are unable to maintain satisfactory pace of play due to the lack of golfing ability. No refunds are available for individuals or groups whose privileges are revoked.

Beverages/Food

All beverages and food to be consumed on the premises must be purchased from the club. **No alcoholic beverages are allowed on the golf course at any time.** No coolers are allowed on the course at any time.

Deposit

In order to reserve a date the must deposit \$350.00 for weekday outings or \$500.00 for weekend outings, with The Club. No dates will be guaranteed until the deposit has been received.

Payment

Payment is due for weekend outings two (2) weeks prior to the event. If payment is not received the reserved tee times will be made available to the public. Payment for weekday outings is due on the day the group commits its final number of players. Payment is to be made in a lump sum, players are not to pay individually. The final number provided by the outing coordinator is a guarantee to the club. **Players who fail to appear will not be deducted from the bill.** (If the organization sponsoring the event does not have a sufficient credit history the club will require a personal guarantee from the outing coordinator for the charges incurred on behalf of the group.)

Cancellation

Weekend outings may be cancelled without penalty if cancelled in writing sixty (60) days in advance of the event. Weekday outings may be cancelled, without penalty, if cancelled, in writing, sixty (60) days in advance of the outing. Any cancellations other than described above will result in loss of deposit. An event cannot be cancelled due to inclement weather unless management has closed the club.

The above represents the entire agreement between the parties and can be changed or modified only in writing that is signed by both parties.
