My goal each day has always been to give Unocal the very best I had to offer. But the rewards I received each day always seemed much greater than anything I had to give. The opportunity to live and work on three continents and in many countries was reward enough in itself. For my family, our lives were enriched by the friendships and respect of people all over the world—people of many races, cultures, religions, and political systems.

The duties of a CEO are many, but first among them is to be the conscience of the corporation. In the final analysis, our corporation is only a document placed in some file cabinet in Delaware. For me, this rebuilding effort has caused a lot of anguish and pain. Downsizing the company was like nonelective surgery. We had to improve cash flow and profitability in order to survive as a strong, competitive company.

Now, however, I believe the ordeal is over. We're no longer focused on survival but poised for growth. I haven't seen so many opportunities for success throughout the world in my 42 years with the company. We'll be a major player in our industry if we work as a team, if we are creative, and if we continue to cherish the high standards of honesty and integrity that have been our hallmark for almost 104 years.

Each of you can enhance your success by applying the acronym "ACE" to your personal and professional lives. ACE stands for attitude... commitment...enthusiasm. It's a simple but effective formula for success.

I leave you in the capable hands of a wonderful Board of Directors and a magnificent leader, Roger Beach. I know you'll give him the same wholehearted support, cooperation and understanding that you've given so generously to me.

As I write the last page of this chapter of my life, I'm eager to begin the chapters that follow. Unocal and its people, its customers, and its shareholders are, and always will be, deeply imbedded in my heart. I'll be proud to carry "the spirit of 76" wherever destiny takes me in the years ahead.

One thing is certain—I'll spend a lot more time with my wonderful wife, Marge, who has been my inspiration for 42 years. We also plan to enjoy more of our four children and seven grandchildren. And I'll continue to give something back to this great country that has been so good to my family and me.
