



Survey of Peer-run Organizations That Have Programs Serving Individuals with Behavioral Health Conditions and Criminal Justice Histories

The United States has less than 5 percent of the world's population, but it has <u>almost a quarter of the world's</u> <u>prisoners</u>. And <u>more than half of them have a mental health problem</u>, according to the Bureau of Justice Statistics. People who live with mental health challenges are <u>less likely to be released on bail</u>, and have <u>longer</u> <u>jail and prison terms</u>. Even when they are released, they are more likely to incur <u>technical probation violations</u>. And this doesn't even take into account how difficult it is for people coming out of jails and prisons to <u>get jobs</u> and <u>housing</u>, which are essential to finding their way back to normal lives.

Because of the enormous need, this survey was developed to identify peer-run programs/services that serve individuals with behavioral health conditions who are returning to the community from jails and prisons. <u>Peer-run organizations have been, and continue to be, leaders</u> in providing cutting-edge, recovery-oriented mental health services and supports; so there is much to learn from their – that is, your – experience.

After these programs are identified, a document will be developed that will include:

- programs doing this work,
- guidelines for program design and/or advocacy initiatives,
- policy recommendations derived from the survey along with interviews of services, and
- an appendix, including:
 - o a bibliography,
 - o organizational contacts,
 - o usable resources,
 - o a dissemination and impact plan.

 - c. Mentor other individuals with behavioral health conditions and forensic histories who are new to the community?
- 11. Do you go into jails and prisons to work with people before their release? If so, how is this arranged?
- 12. What training is offered to staff to provide these services? Please describe.
 - a. To do this work, do you employ forensic peer specialists and/or peer specialists without a forensic background?
- 13. Describe any barriers you faced in the implementation of the program and how you overcame them or how they changed the program.
