I, the undersigned, hereby affirm that having placed my witnessed autograph on the attached:

- 3. Declaration of Domicile and Political Status



that I am a jurist and elector in the First Estate of \_\_\_\_\_ County, Texas, which also participates as Congregation \_\_\_\_\_ of the Texian Jural Society and as Congregation \_\_\_\_\_ of the National Jural Society, and is that certain society of sovereign souls domiciled on the land described by the boundaries of Texas, and each Texas county, that peaceably and lawfully Assemble in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common Defense, promote the general Welfare, and secure the Blessings of Liberty for our Posterity and our free and independent county and state and the Honor of our County, State, and Country and to provide, grand juries within the Texian Jural Society for each county, the state and the national causes of action, such juries to be known as the:

respectively, and to provide three separate and distinct republican forms of government, including one for the county, one for the state and one for the national; and to these ends does each sovereign soul solemnly and mutually, covenant and combine themselves together into a civil Body Politic, for their better Ordering and Preservation, and Furtherance of the Ends aforesaid; Further, does each Texian sovereign soul solemnly and mutually pledge to each and every other Texian sovereign soul to come to their defense against any unjust or unrighteous assault or threat, either by direct or indirect acts, on any Texian sovereign soul's life, liberty or property; And by Virtue hereof to enact, constitute, and frame, such just and equal Laws, Ordinances, Acts, Constitutions and Offices, from time to time, as shall be thought most meet and convenient for the General good; unto which we promise all due submission and obedience.

I pray that I may always act in a manner that honors all of the above and will insure that we will always have a lawful, righteous and just government that truly represents the Texian People. That my purpose and goal will always be liberty, by learning to become a better sovereign jurist and elector and will to the best of my ability insure the continued process of electing righteous and just fellow sovereigns to hold the government offices.
