Four (4) equal remaining payments of \$530.00 are due at 30 days, 60 days, 90 days, and 120 days from the date of the start of training. Failure to fulfill payment requirements will cease student's ability to continue the program. Program includes a weekly yoga single class pass at Alchemy Studio, LLC, for the duration of the Teacher's Training Program at no cost to the student. Additional materials (books, paper, etc.) are to be provided by the applicant. See attached Materials List. If paying by check: payable to Alchemy Studio, LLC. Any variation from the two above-stated payment plans require discussion and pre-approval in writing by Alchemy Studio, LLC.

Refund policy:

All tuition and deposit amounts paid by the applicant shall be refunded if the applicant is rejected by the school before enrollment. An application fee of not more than \$25.00 will be retained by the school if the applicant is denied. All tuition and fees paid by the applicant shall be refunded if requested within three (3) business days after signing a contract with the school. All refunds shall be returned within thirty (30) days. There will be no refunds issued after the allowed three (3) business days after contract signing. Attendance Policy:

In order to meet Yoga Alliance's Requirements, students must attend the 206 contact hours of class time required. All noncontact requirements (homework, projects and other assignments) must be completed, submitted and approved in order to complete the program and receive a certificate of completion.

Level of Training

This training is geared toward meeting all requirements of Yoga Alliance's 300 hour level teacher training guidelines. As such, no credit can be given for previously attended yoga trainings outside of this program.

Program Completion Requirements

- 206 contact hours;
- All noncontact hour assignments completed, submitted and approved;
- Completion of all tests and quizzes in the program;
- Full payment of tuition;
- Adherence to the studio and training program ethical standards and best practices;
- Any and all materials borrowed from the studio or the program returned.

Completing the program does not guarantee certification. Alchemy Studio, LLC, and lead trainer Lisa Holzer, reserve the right to refuse certification to any student that does not display proficiency in the training material or adherence to the studio’s ethical standards set forth in the syllabus.

Removal from the training program at any time ‘with cause’ and without refund can occur for the following reasons:

1. Student is charged with a felony crime during the training period (it is the student’s responsibility to inform the studio of any such charge);
2. Student commits a crime of moral turpitude such as an act of fraud, theft, or other crime involving dishonesty;
3. Student fails to comply with training directives from lead trainer, the studio’s managing officers, or written studio policies;
4. Student commits any act or acts that harm the studio’s reputation, standing, or credibility within the community(ies) it operates or with its customers or suppliers;
5. Student shares the studio’s copyrighted training materials with others outside the studio’s training program.

Grading is based on completing the program. Upon completion of all program requirements, and at the trainer’s discretion, a certificate will be issued that training at the 300 hour yoga teacher level has been completed. The certificate will then allow the student to apply for registration through Yoga Alliance at the 300 hour level and will register the student as an RYT-500 teacher.
