It shows. 7 And thank you for appreciating that. 8 MR. MORIN: The auditors were here today. 9 MR. NATERA: Oh, by the way, yes, the 10 auditors were just here. And Ms. Debbie Dillon 11 kicked them all out of here. 12 MR. MORIN: Kick them out. MR. NATERA: So, -- yeah, so we were on 13 time for the meeting. 14 15 And so far so good. We already had the 16 exit meeting and it was wonderful. 17 And just like the Chairman like to hear, no 18 findings whatsoever at all. And the 24 financial 19 score that we had already in the unaudited FDS, 20 we remain exactly the same at 24. 21 Right, so they will be coming back tomorrow 22 just to wrap just one little aspect that is 23 there, besides with the contracts. And that will 24 be the end of it. 25 Actually the end of the audit.
