### Legislative Work

In March 2010, he testified in front of the Florida Senate on behalf of the Florida Yacht Brokers Association, Marine Industries Association Florida and the Marine Industries Association of South Florida. June of 2010, the Florida legislature capped sales and use tax at \$18,000.
