BOOTH FEES AND EVENT DETAILS CONTINUED

- All applications are due by Friday, April 25, 2014, along with a \$50 nonrefundable deposit. This deposit will be applied towards your booth fee. Applications received after this date must pay with cash, money order or cashier's check.
- Exhibitors will be notified on or before Monday, April 28, 2014, that their application has been approved.
- All prior year returning exhibitors will take precedent for booth placement, but application and fees must be received by the due date. All other exhibitors will be placed based on a first come, first paid basis.
- Event gates open to general public at 2:30 pm, set up can begin on Saturday, May 3rd at 10:00 am. Your vehicle must be away from the vendor area, and in designated parking area by 2:00 pm. Events begin at 3:00 pm, with the rodeo performance starting at 6:30 pm, followed by concert at approximately 9:00 pm. All booths must remain open between the hours of 2:30pm – 10:30 pm. You will be able to move your vehicles in for load up at 11:00 pm. **DEPENDING ON YOUR BOOTH LOCATION, YOU MAY BE ASKED TO WAIT PAST 11:00 FOR THE SAFTY OF THE GENERAL PUBLIC.**
- You must be removed from premises by Sunday, May 4, 2014 at 9:00am.
- Exhibitors are responsible for leaving their area clean and free of trash.
- Exhibitors are responsible for tables, chairs, tents, trailers, stands, extension cords, linen, etc.
- The Corral Club reserves the right to approve or disapprove of the exhibit material without recourse.
